

THE PORTSMOUTH CITY COUNCIL TRAFFIC REGULATION (SPECIAL EVENTS) ACT 1994

The Portsmouth City Council (St Jude's C of E Primary School - School Street) (Temporary Prohibition of Driving) (No.70) Order 2021

The Portsmouth City Council (hereinafter referred to as 'the Council'), in exercise of its powers under Section 16 of the Road Traffic Regulations Act 1984 ('the Act'), and of all other enabling powers, and after consultation with the Chief Officer of Police and Secretary of State in accordance with Part III of Schedule 9 to the Act hereby make the following Order:

1. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
2. Save as provided in Articles 3 and 4, no person shall, except upon the direction or with the permission of an officer authorised by the Highway Authority or their Agents, cause or permit any vehicle to proceed through the roads and lengths of road specified in the First Schedule.
3. Nothing in Articles 2 shall apply to any vehicle being used for Police, Fire and Rescue Service, Doctor or Ambulance purposes, or by a statutory undertaker in an emergency, which necessitates the bringing of vehicles into the road and lengths of road to which the Order applies.
4. Nothing in Articles 2 shall apply to any authorised vehicle requiring access to the lengths of roads referred to in the First Schedule. Authorised vehicles include those authorised by the school, including those driven by residents and carers of residents of the street, Special Educational Needs and School transport assistance, Blue Badge Holding teachers, pupils and parents, carers, and other staff at the school where the restriction is in force.
5. This Order may be cited as The Portsmouth City Council (St Jude's C of E Primary School - School Street) (Temporary Prohibition of Driving) (No.70) Order 2021 and shall come into operation from 29th June 2021 to 17th December 2021.


